MFCU Scholarship Award

Muskogee Federal Credit Union will award a one time \$500 scholarship to a 2019-2020 graduating high school senior or to a continuing education student.

Applicant and/or parent/guardian must own or establish a MFCU share account as the primary owner. The account must be in good standing. The applicant must be planning to attend an accredited two-year or four-year college, university or vocational-technical school.

Prior to funding the scholarship, the recipient must submit documentation of enrollment. Scholarship funds must be used by October 1, 2020 or the student forfeits the scholarship.

The completed application must be received by March 16, 2020. It may be turned in to any of our 3 locations: 1910 W Shawnee or 3502 Chandler Rd in Muskogee or 4595 S Muskogee Ave in Tahlequah. Or mail to the address below to be received by March 16, 2020.
